# Skills qualification and professionalization: the key for foreign citizens to live and work in Italy.

This is, in short, TRAIETTORIE, the project that was created to encourage the entry of foreign citizens interested in living and working in Italy and to create the conditions for an adequate **job placement** that is the basis of a path of **economic independence** and **social inclusion**.

**Beneficiaries** of the project are **foreign citizens of Albania**, **Ivory Coast, Gambia and Senegal** who, at the end of an adequate preparation in their countries of origin, will be able to be **placed in international internships**, **be hired as seasonal workers**, **start self-employment**.

TRAIETTORIE works in close collaboration with the Prefectures, Embassies and the Emilia-Romagna Region to promote knowledge of Italian legislation aimed at the regular entry of foreign citizens and the opportunities that can be seized by the entrepreneurial fabric.

# Objectives —

• develop skills useful for socio-occupational integration in Italy, such as Italian language, civic education, workplace safety, Italian immigration legislation, specific professional skills;

- favour the circulation of correct and useful information on immigration to foreign citizens and host companies;
- accompany foreign citizens in carrying out the bureaucratic procedures necessary for regular entry into Italy;
- support foreign citizens interested in starting entrepreneurial activities in Italy.

## Beneficiaries — -

**350 foreign citizens** will attend training courses in Italian language, civic education, professional qualification, occupational safety and Italian legislation on immigration in their own countries according to this distribution: Albania 160, Ivory Coast 50, Gambia 50, Senegal 90. **10 foreign citizens** will follow the path to self-employment.
